VILLAGE OF HEUVELTON

Regular Board Meeting March 13, 2024

At 6:00 pm, Mayor Lashua called the meeting to order, she opened the meeting with the pledge of allegiance. Trustees in attendance were Trustee A. Guardino, Trustee M. Hebert, Trustee E. Wood, and Trustee C. Basford. Also, in attendance was A. Spaman, DPW Supervisor. T. Haynes & C. Fout, DANC; and J. Lightfoot SLC Legislator.

Public Forum Mr. Lightfoot updated the Board on county matters. He left at 6:21.

HVFD Report The Board discussed the tentative fire district.

RESOLUTION 24-017 FORM FIRE DISTRICT

Offered by Mayor Lashua, seconded by Tr. Basford. All in favor

WHEREAS, the Town Boards of the Towns of Oswegatchie and DePeyster and the Board of Trustees of the Village of Heuvelton having duly convened on February 27, 2024, in joint session for the purpose of jointly considering the formation of a joint fire district, to be called the "Heuvelton Volunteer Fire District", pursuant to the provisions of section 189-a of the Town Law and section 22-2210 of the Village Law; and

WHEREAS, such fire district would include all parcels of land within the incorporated limits of the Village of Heuvelton and all parcels of land in the Towns of Oswegatchie and DePeyster; and

WHEREAS, the Town Boards of the Towns of Oswegatchie and DePeyster and the Board of Trustees of the Village of Heuvelton have each caused Notice of a Joint Public Hearing to be published in the North Country This Week on February 16, 2024; and

WHEREAS, the Town Boards of the Towns of Oswegatchie and DePeyster and the Board of Trustees of the Village of Heuvelton have caused Notice of a Joint Public Hearing to be posted in five public places within the fire protection districts within the Towns of Oswegatchie and DePeyster and five public places within the Village of Heuvelton for at least ten days; and

WHEREAS, the Town Clerks for the Towns of Oswegatchie and DePeyster and the Village Clerk for the Village of Heuvelton mailed Notice of the Joint Public Hearing to each of the members of their respective governing bodies, at least ten days in advance of the Joint Public Hearing; and

WHEREAS, the Town Boards of the Towns of Oswegatchie and DePeyster and the Board of Trustees of the Village of Heuvelton held a joint public hearing on February 27, 2024 at 7:00 p.m. at the Heuvelton Fire Department's Firehouse, located at 95 State Street, Heuvelton, New York, at which time the Boards heard all those wishing to be heard on the question of the formation of said joint fire district; and

WHEREAS, the creation of the Heuvelton Volunteer Fire District is agreed to be contingent upon the dissolution of the Fire Protection Districts in the Towns of Oswegatchie and DePeyster; and

WHEREAS, said Town Board and Board of Trustees have considered the evidence and objections presented at said public hearing.

NOW, THEREFORE, BE IT HEREBY RESOLVED AND ORDERED, that, it is in the public interest to form the said Heuvelton Volunteer Fire District, that all property, property owners and interested persons in the proposed fire district are benefitted thereby, all property and property owners benefited are included therein, and only such property and property owners as are benefited shall be included therein, and that said joint fire district be, and hereby is formed and established subject to permissive referendum as provided in sections 90 and 189-a of the Town Law, and

IT IS FURTHER RESOLVED, that subject to the provisions of section 189-e of the Town Law, the property and affairs of the Heuvelton Volunteer Fire District shall be under the management and control of an elected board of five fire commissioners, elected each year by the voters of the District, pursuant to Article 11 of the Town Law, but whose initial appointments shall be for the terms set forth in section 189-e of the Town Law; and

IT IS FURTHER RESOLVED, that pursuant to section 189-e of the Town Law, the Town Boards of the Towns of Oswegatchie and DePeyster, after consultation with the Village Board of the Village of Heuvelton, hereby will appoint five persons as the initial commissioners at a later session;

IT IS FURTHER RESOLVED, that the Heuvelton Volunteer Fire District shall have all the powers enumerated in Article 11 of the Town Law, Section 176, including but not limited to the power to acquire or

purchase easements or property, both real and personal, as well as dispose of easements or property, both real and personal,

without any further approval of the boards of the Towns of Oswegatchie and DePeyster and the Village of Heuvelton; and

IT IS FURTHER RESOLVED, that subject to the provisions of section 189-g of the Town Law, there shall be a treasurer appointed by the Board of Fire Commissioners annually; and

IT IS FURTHER RESOLVED, that the creation of the Heuvelton Volunteer Fire District is contingent upon the dissolution of the Towns of Oswegatchie's and DePeyster's Fire Protection Districts, and

IT IS FURTHER RESOLVED, that upon the passage of the time for a permissive referendum as provided in sections 90 and 189-a of the Town Law, the Town Boards for the Towns of Oswegatchie and DePeyster and the Board of Trustees of the Village of Heuvelton shall meet to pass resolutions related to the confirmation of the initial appointment of five fire commissioners who shall be hereafter elected pursuant to Article 11 of the Town Law, the transfer of firefighting assets of the Village of Heuvelton to the Heuvelton Volunteer Fire District and the transfer of funds, related to the provision of fire protection, from the Towns of Oswegatchie and DePeyster and the Village of Heuvelton.

Water/Sewer Mr. Fout gave a report on the water and sewer operations. Mr. Haynes discussed the I&I grant. DANC will create an agreement to facilitate this project. The Board reviewed the O&M agreement with Mr. Fout. Mr. Spaman notified everyone where he was at with the lead line inventory. Mr. Haynes explained the resolutions for the sewer project. Mr. Haynes and Mr. Fout left at 7:24. Mayor Lashua reviewed sewer project status. The Board discussed the land on the Taylor Road and sewer equipment that will not be useful.

WHEREAS, the Village of Heuvelton Village Board (hereinafter "Board") believes that the lack of housing for New York residents of all ages and income levels negatively impacts the future of New York State's economic growth and community well-being;

WHEREAS, the housing crisis has negative effects at regional and local levels, the Board believes that every community must do their part to contribute to housing growth and benefit from the positive impacts a healthy housing market brings to communities;

WHEREAS, the Board believes that supporting housing production of all kinds in our community will bring multiple benefits, including increasing housing access and choices for current and future residents, providing integrated accessible housing options that meet the needs of people with sensory and mobility disabilities, bringing economic opportunities and vitality to our communities, and allowing workers at all levels to improve their quality of life through living closer to their employment opportunities;

WHEREAS, the Board believes that evidence showing that infill development that reduces sprawl and supports walkable communities has significant environmental and public health benefits; and

WHEREAS, the Board believes that affirmatively furthering fair housing and reducing segregation is not only required by law, but is essential for keeping our community strong and vibrant;

NOW, THEREFORE, IT IS HEREBY RESOLVED that the Village of Heuvelton Village Board, in order to take positive steps to alleviate the housing crisis, adopts the Pro-Housing Communities pledge, which will have the Board endeavor to take the following important steps:

- 1. Streamlining permitting for multifamily housing, affordable housing, accessible housing, accessory dwelling units, and supportive housing.
- 2. Adopting policies that affirmatively further fair housing.
- 3. Incorporating regional housing needs into planning decisions.
- 4. Increasing development capacity for residential uses.
- 5. Enacting policies that encourage a broad range of housing development, including multifamily housing, affordable housing, accessible housing, accessory dwelling units, and supportive housing.
