Public Forum Mr. Lightfoot updated the Board on County issues. There has been talk of eliminating the 4% sales tax on home heating fuel which would affect revenues for municipalities. Public Health has started an opioids task force. The next meeting is January 18th at 10am in Canton. The County Jail needs a new security system at a cost of \$800,000. Mr. Lightfoot left at 7:46pm.

Sewer/Water Mr. Kevin Feuka addressed the Board on the status of the Equalization Tank Project with Losurdo. The bids came in over budget. They are working on additional grant funding. Losurdo will be doing some of the electrical, plumbing and mixer installation to save costs. The project should be done by the fall. He stated that the Notice of Award is ready to be issued to Continental Construction who was the lowest bidder.

Mr. Prior addressed the Board on the progress of the Sewer Consolidation survey. He gave a brief outline of the proposed route along Route 812. He hopes to have more information by the end of the month. He discussed the possible grant and funding sources available. Mr. Prior left at 6:55pm.

The Mayor discussed the lagoon tear. The well at the WWTP had a negative test. The well monitoring will continue and additional area wells will be added to the testing. There will be a meeting with DEC in the future to discuss options.

Mr. Feuka stated the land apply application will sent in at the end of February. He left at 7:46pm.

Mayor's Report The Mayor updated the Board on the progress of the Property Project. The purchase offer is with the lawyer. Mr. Prior discussed the process going forward. The Environmental Assessment Form is completed and the Village can proceed with declaring themselves as lead agency and SEQR. She also discussed the bond counsel agreement for the project.

Village of Heuvelton Property Acquisition, 100 State Street, Heuvelton

WHEREAS, the Village of Heuvelton, hereinafter referred to as the "Village", is proposing to cause to be demolished a building at 100 State Street to construct a parking lot to serve Village residents, businesses and institutions; and

WHEREAS, the Village of Heuvelton Board of Trustees must evaluate all proposed actions submitted for its consideration that may affect the environment in light of the State Environmental quality Review Act (SEQRA) and the regulations promulgated thereunder; and

WHEREAS, the involved agencies as that term is defined in 6(A-2) NYCRR 617.2(t) include the Development Authority of the North Country, Dormitory Authority of the State of New York, St. Lawrence River Valley Redevelopment Agency and the New York State Department of Transportation, and the required environmental review will be conducted solely by the Village of Heuvelton Board of Trustees: and

WHEREAS, the Village of Heuvelton Board of Trustees desires to serve and act as the lead agency for the purposes of SEQR; and

WHEREAS, to aid the Village of Heuvelton Board of Trustees in determining whether the Action may have a significant impact on the environment, a Short Environmental Assessment Form dated January 9, 2019 has been prepared by the Village and a copy of which has been filed with the Village Clerk.

NOW, THEREFORE, BE IT RESOLVED by the Village of Heuvelton Board of Trustees that: The Village of Heuvelton Board of Trustees makes the following findings and determinations with respect to the proposed project:

The project action would be classified as "Unlisted" in accordance with New York State Codes, Rules and Regulations (part 617.4). The Village of Heuvelton Board of Trustees desires to serve as lead agency for the purposes of SEQR.

The Village Clerk shall cause the Development Authority of the North Country, Dormitory Authority of the State of New York, St. Lawrence River Valley Redevelopment Agency and the New York State Department of Transportation as the other "involved agencies" to be notified of this resolution.

This resolution shall take effect immediately.
