## Regular Board Meeting June 10, 2015

At 6:00 pm, Mayor Lashua called the meeting to order. Mayor Lashua opened the meeting with the pledge of allegiance. Trustees in attendance were Wood, Parish, Guardino and Knowlton. **HVFD Report** The TA80 project is on hold. According to Northern Fire, E106 will be ready at the end of June. Chief Friot left at 6:25 pm.

**Sewer/Water** The sewer lines under the river were found plugged on June 1, 2015. The new Jetter was used to unplug the line. SunOpta broke down last week; they have not upped production yet. Mr. Rowe left at 6:32 pm.

**Public Forum** Mr. Lightfoot informed the Board that sale tax receipts were down. The County Court Judge must be asked to remove restrictions on pistol permits. A bill must be sponsored in order to keep the 1% sales tax. Mr. Lightfoot left at 7:13 pm.

Mayor's Report

The Mayor and the Board discussed a caucus date of July 8<sup>th</sup>, at 5:15 pm. The Mayor informed the Board that Bruce Donnelly would be resigning from the Zoning Board at the end of July and that Amber Riordan has resigned from the Planning Board. Sally Bissell is also resigning from the Planning Board. Betsy Willard and Chris Hayes were suggested as replacements. A letter should be sent to Betsy Willard and Chris Hayes to see if they are interested in becoming members of the Planning Board. It was also suggested that Ken Cole would be a good candidate for the Zoning Board of Appeals. The Mayor read a letter from the Town of Oswegatchie Board requesting the Village consider helping with the cost of patching the front steps. The Board discussed the issue with paving. The Board will go to the next Town of Oswegatchie Board meeting to discuss shared services.
