# **Regular Board Meeting** June 14, 2023

At 6:00 pm, Mayor Lashua called the meeting to order. Mayor Lashua opened the meeting with the pledge of allegiance. Trustees in attendance were Trustee E. Wood, Trustee A. Guardino, Trustee C. Basford, and Trustee M. Hebert. Also, in attendance were A. Spaman, DPW Supervisor and T. Harris, HVFD Assistant Chief. J. Lightfoot, SLC Legislator arrived at 6:08pm.

**Public Forum** Mr. Lightfoot updated the Board on county matters. He left at 7:30pm.

**HVFD Report** Mr. Harris informed the Board the cookout for yard sale day was successful. The water hauls were very busy but they are beginning to slow down. Mr. Harris left at 6:05pm.

Sewer/Water Mayor Lashua gave an update for water and sewer. She informed the board DANC is applying for a grant for the Village to study sewer infiltration. The Board discussed the investigation of sewer lines at the Village limits on Route 184. The lagoon is full and the Village will need to haul. DANC suggested two loads per week. The Mayor gave project updates. They discussed the fence around the water tower.

RESOLUTION IN SUPPORT OF A NEW YORK STATE ENVIRONMENTAL FACILITIES CORPORATION WASTEWATER INFRASTRUCTURE ENGINEERING PLANNING GRANT APPLICATION FOR THE VILLAGE OF HEUVELTON INFLOW AND INFILTRATION PROJECT

Offered by Tr. Guardino, seconded by Tr. Basford. All in favor.

WHEREAS, a notice of funding availability from the 2023 New York State Environmental Facilities Corporation Wastewater Infrastructure Engineering Planning Grant program was announced with a total of \$3,000,000 available to help municipalities complete a Preliminary Engineering Report for future funding to correct wastewater infrastructure deficiencies: and

WHEREAS, the Village of Heuvelton seeks to remove inflow and infiltration from the Village sewer collection system to reduce high wet-weather flows, reduce system operation and maintenance costs, and restore capacity for future growth of residential and commercial development; and

WHEREAS, grant funding from the New York State Environmental Facilities Corporation Wastewater Infrastructure Engineering Planning Grant program would greatly assist the Village in contracting an engineering firm to prepare a Preliminary Engineering Report that identifies the scope of needed improvements, total estimated project cost, and a schedule to complete the work; and

WHEREAS, the Village of Heuvelton Village Board fully supports a proposed funding application. NOW, THEREFORE, BE IT:

**RESOLVED** that the Village Mayor is hereby authorized and directed to file an application for \$50,000 in grant funds from the New York State Environmental Facilities Corporation Wastewater Infrastructure Planning Grant Program to minimize planning costs to the Village of Heuvelton sewer customers; and BE IT FURTHER RESOLVED that the Village of Heuvelton Village Board authorizes and obligates the sum of \$10,000 to provide the required 20-percent local match funds to secure the State grant; and **BE IT FURTHER RESOLVED** that the Village Mayor is hereby authorized to serve as the Village's representative to execute all documents and agreements associated with the funding upon award.
