Regular Board Meeting June 9, 2021

At 6:00 pm, Mayor Lashua called the meeting to order. Mayor Lashua opened the meeting with the pledge of allegiance. Trustees in presence were Trustee E. Wood, A. Guardino and Trustee C. Basford. Trustee W. Knowlton was absent. Also, in attendance were T. Murray, DPW Supervisor; T. Wood, HVFD Chief; McConnell, DANC; and C. Prior, EDR. From the public was Mr. Tacchino and Mr. Felt from SLFCU. J. Lightfoot, SLC Legislator arrived at 6:05.

Mayor Lashua Opened the Public Hearing at 6:01.

Public Forum Mr. Lightfoot updated the Board on county matters.

HVFD Report Chief Woods gave a report to the Board. They are up to 46 members. The BBQ this past weekend went well. They have been remarkably busy with calls. The tanker trailer is going to be sent to get some work done to it very soon. They are considering a major renovation project; it is just in the beginning planning for down the road two to three years.

Sewer/Water Mr. McConnell gave an update; water and sewer is running well, and he is keeping up with maintenance.

Mr. Prior addressed the Board with information regarding the Sewer Consolidation Project: Easements are still being worked out. Bids are estimated to be released July 5th with around August 20th for opening. He also discussed the solar project. The timelines do not match up with the sewer project so the Village may need to explore other options for sludge.
