# VILLAGE OF HEUVELTON

Regular Board Meeting May 13, 2015

At 6:00 pm, Mayor Lashua called the meeting to order. Mayor Lashua opened the meeting with the pledge of allegiance. Trustees in attendance were Wood, Parish, Guardino and Knowlton. Also in attendance were T. Murray, DPW Superintendent, N. Friot, Chief, HVFD, S. Rowe, DANC, and T. Burley, C2ae. J. Lightfoot, SLC Legislator arrived at 6:27 pm.

HVFD Report

The Chief reminded everyone that the banquet for Jack Wood for Fireman of the Year is on Saturday, May 16<sup>th</sup>, cocktails at 6:00 pm and Dinner at 7:00 pm. We are on track to get the new fire truck on May 22<sup>nd</sup>. DANC is checking with the County on a communications grant they received to see if a section from the bridge to the Fire Department can be included. The Chief is also checking to see what the cost of telephone and internet would be from TWCNY instead of Verizon. The Chief left at 6:18 pm.

Mr. Rowe met with Losurdo's; there was a discussion about not using the equalization tank. This topic has been brought up before. The Board would like Mr. Rowe to get with Mr. Stellar at Losurdo's to have him contact Mr. Backus to check out the potential new design without the equalization tank. All industries were in compliance this month. Two blowers have been running at the WWTP. Five airlines were fixed; more diffusers need to be ordered. Mr. Rowe will contact the DEC to check on the permits to spread sludge and also contact Lawton's concerning a pump. The SOP's for the backup well will be sent to P. Pastella, and also the DPW. Tim Murray will check with Moody's about the greasing intervals for the motor at the tower. Kevin Wallace no longer works for DANC, his replacement is Allen Fleming. Mr. Rowe left at 6:42 pm.

**Public Forum** Mr. Burley updated the Board on the Water Project which is going to be listed as a phase type project. He also updated them on the Sewer Rehab Project. There was a discussion on a cover for the clarifier. There was a discussion about the pump purchased from Emerick. There was a discussion about the Crobar lateral. The cost will be approximately \$18,400 without paving. A sub-contractor will be doing the final paving. Mr. Burley left at 7:30 pm.

Mr. Lightfoot updated the Board on happenings at the County. He informed the Board that there was going to be a Notice of Claim in the paper on May 14<sup>th</sup> against Ms. Rain. Ms. Rain is being represented by her own counsel. There was discussion about revising the law on pistol permits and also revising the law on fireworks to allow the sale of sparklers. There was also a discussion about an easement to Clifton Fine for a boat washing station. The County hired two new attorneys. They have not passed the bar yet. A deal was worked out with the law school concerning their salaries. The County will be going back to the State to request to continue the 1% sales tax increase. The County gave Bass Masters \$60,000. There will be a meeting with the Amish at the fire hall on May 21<sup>st</sup> to discuss putting triangles on their buggies. The County honored the Lady Bulldogs on May 4<sup>th</sup> for be the State Champions.

Ogdensburg: \$2,207 per day, approximately \$4400, cannot be done until September. There was a discussion about hiring Millers Greenhouse to clean up Murdock Park. The Board discussed ordering winter and spring banners for the Village. The Mayor informed the Village that Brookfield will be putting a portage route around the Heuvelton Dam in 2017. The SLC Mayor's Association dinner is June 3<sup>rd</sup>, at the Lobster House, Norwood. There was a discussion about using a different supplier for electricity instead of National Grid.
